



fter a two-year break due to the COVID-19 pandemic, the Trade Fair of OIC Member States returns for its 17th edition from 13 to 19 June 2022 in Dakar. This biannual event represents the flagship commercial event of the Organization of the Islamic Cooperation, since it allows private and public economic operators from OIC Member States to explore opportunities to increase intra-OIC trade and investment.

The OIC has 57 member countries, located in Asia, Africa, Middle East and America, representing no less than 2 billion potential consumers with more than 50% of young people under the age of 25. So it's a very promising and growing market, with countries that are experiencing growth in domestic consumption and investment.

The choice of Senegal, one of the dynamic members of the OIC, to host this edition stems from the importance of this country as a catalyst for growth in the West African region. It must be said that this country, under the enlightened leadership of His Excellency Macky Sall, President of the Republic, has taken important steps to bring the business environment up to international standards. Indeed, this country is becoming very attractive for IDEs in the Islamic world thanks to the «Emerging Senegal» strategy.

The Dakar edition, inspired by this new dynamic, is an opportunity to breathe new life into the partnership between OIC member

countries, especially in the post-COVID period. With a total area of sqm 56,000, made available to exhibitors, this edition aims to create a real business space in various sectors. The objective is to develop, diversify and sustain commercial relations between the business communities of the OIC area.

The Fair is also a real opportunity to seek ways and means to boost intra-OIC cooperation and partnership, in a logic of strengthening regional economic integration, targeting key sectors for value chain development and sectoral complementarities. In this regard and on the sidelines of the fair, a Business Forum Senegal-OIC during which the host country will present its investment climate as well as the partnership potentialities in

the framework of specialized sectoral deal rooms focused on bankable investment projects.

The Investment Promotion Agencies of the OIC countries will also meet to develop a policy dialogue to seize the opportunities offered in the OIC space through, the exchange of experience and the creation of conditions for innovation in the promotion and marketing of products and services.

In addition, and as part of the ongoing exchange of expertise and capacity building in trade-related fields, two training workshops will be held on the knowledge economy and on the "Halal" certification of food products, respectively.

This 17th edition offers all the conditions facilitating access to information on the potential of the markets and the making of direct contacts between the economic actors of the public and private sectors of the participating countries.

The CIDC expresses its thanks and gratitude to the Senegalese authorities, and more particularly His Excellency the President of the Republic, for all the facilities offered to make this event a success.
